Handling Policy of Personal Information

We, Japan Remit Finance Co., Ltd. ("We" or "Company") disclose the following matters based on the "Act on the Protection of Personal Information" (hereinafter referred to as the "Act").

1. Matters concerning the Publication of the Purpose of Use of Personal Information

When obtaining personal information directly or indirectly, we will use personal information of customers to the extent necessary to achieve the following purposes of use.

Provided, however, that in the event personal information in writing is obtained directly from a customer, the purpose of use shall be clearly indicated in advance.

In addition, we shall specify the purpose of use in a concrete manner so that the purpose of use is clear for customers. For example, when responding to various questionnaires, we shall endeavor to limit the purpose of use in accordance with the circumstances of acquisition, for example, by using the questionnaire only for the aggregation purposes.

- 1. For membership registration and service provision of international remittance services
- 2. In order to confirm the qualifications for using the services, etc. pursuant to the Criminal Proceeds Transfer Prevention Act, the Foreign Exchange Act, Act on Submission of Statement of Overseas Wire Transfers for Purpose of Securing Proper Domestic Taxation, and other relevant laws and regulations
- 3. For the purpose of properly performing the entrusted operations in cases where all or part of the processing of personal information is entrusted by another entity, etc.
- 4. For the exercise of rights and fulfillment of obligations under contracts and laws with customers
- 5. For research and development of services through market research and data analysis and questionnaire surveys, through which we shall be able to offer our products and services suitable for your interests and preferences
- 6. For various proposals related to services such as direct mailing to advertise our products and services suitable for your interests and preferences
- 7. To propose various products and services of affiliated companies suitable for your interests and preferences
- 8. For cancellation of various transactions and a post management subsequent to cancellation of transactions
- 9. For proper and smooth execution of transactions with customers

Provided, however, that in the event the purpose of use of specific personal information is limited in accordance with laws and regulations, the Company will not use such information for any purpose other than the said purpose. To be more concrete, pursuant to Article 26 of the Cabinet Office Ordinance on Funds Transfer Service Providers, when a Funds Transfer Service Provider handles information on the race, creed, family origin, domicile of origin, health and medical care, criminal background, or any other special non-public information (meaning unpublished information that has come to be known in the course of its business), it shall not use or provide such information for any purpose other than for ensuring the appropriate operation of its business or for any other purpose that is found to be necessary.

In accordance with the Act on the Use of Numbers to Identify Specific Individuals in Administrative Procedures, we will not obtain, use, or provide personal information that contains the customer's Individual Numbers and Individual Numbers to a third party for purposes other than the purpose of use permitted by the Act.

2. Proper Acquisition and Maintenance of Personal Information

We will properly obtain the personal information of our customers.

For example, we may obtain personal information from the following sources, and maintain personal information at the localized servers with the adequate security protection implemented by our Company.

(Examples of Information Sources to be Obtained)

In the event you are directly provided with data entered on our website by the customer and documents to be completed and submitted by the customer, such as the membership registration application form.

3-1. Provision of Personal Information to Third Parties

We will not provide personal information in our possession to a third party without the consent of the customer, except when entrusting such information to a third party, when providing such information upon succession of business due to a merger or other reason, when sharing such information, or in the following cases:

- 1. Cases based on laws and regulations
- 2. The case where it is necessary to protect the life, body, or property of an individual and it is difficult to obtain his or her consent

- 3. When it is particularly necessary for the improvement of public health or the promotion of the sound upbringing of children and it is difficult to obtain the consent of the relevant person
- 4. Cases in which it is necessary to cooperate with a state agency, a local government, or a person entrusted by the said agency in executing the affairs prescribed by laws and regulations and in which obtaining the consent of the person in question is likely to impede the execution of the affairs in question
- 5. Cases in which a third party needs to handle said personal data for academic research purposes (including cases in which a part of the purpose of handling said personal data is for academic research purposes, and excluding cases in which there is a risk of unjustifiable infringement of the rights and interests of individuals)

In addition, we conclude a contract with a contractor to establish the information security system to strictly handle personal information in accordance with our information security standards and will ensure appropriate security control measures.

For example, we entrust the handling of personal data with respect to the following operations. (Example of Entrusted Affairs)

- Processes related to sending documents related to various procedures
- Affairs related to the dispatch of direct mail
- Operations with respect to system operation and maintenance
- Operations involved in receiving our international remittance service
- Office work in response to customer inquiries
